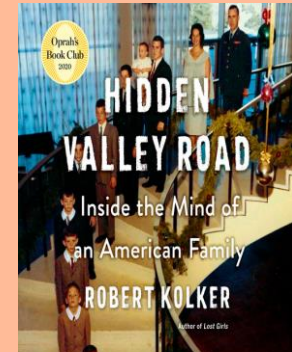
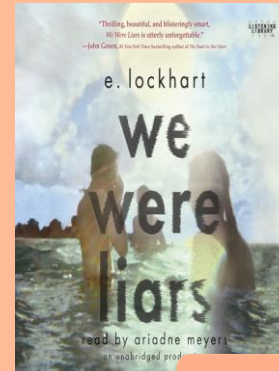




ARPA legislation requires that funds for materials

June 1, 2021 – September 30, 2022.

One Copy/ One User

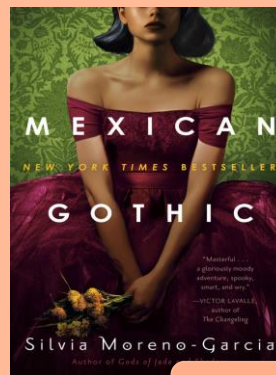
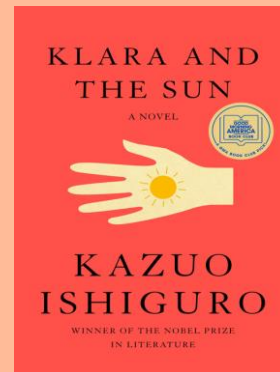
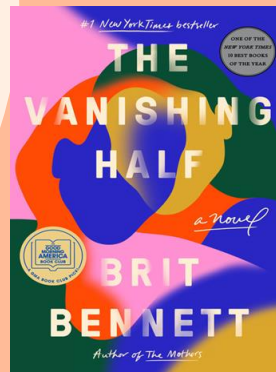
- One Copy/One User (OC/OU) **does comply** because it's perpetual use.
- When you create a new cart for OC/OU, you can optionally **designate it to use ARPA funds**.
- Invoices for ARPA purchase orders (from ARPA designated carts) **will be separated** to let you easily track spending and issued at time of purchase.

Metered Access

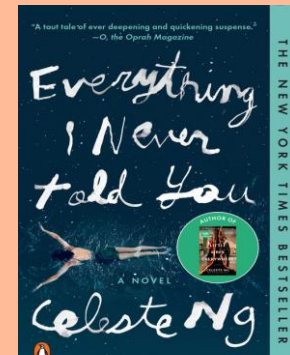
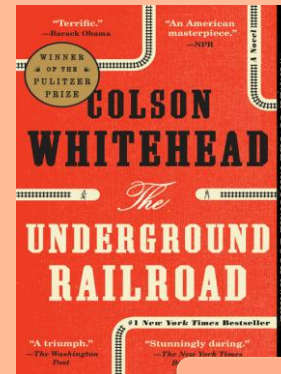
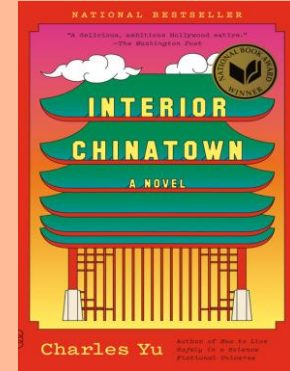
- Metered Access (MA) by time **does comply** if it expires on or before September 30, 2022.
- Metered Access (MA) by checkout **does not comply** because checkouts may not be exhausted on or before September 30, 2022.
- Ebooks from Penguin Random House, Dorling Kindersley, and (soon) Macmillan, in the Metered Access 24-month lending model **are available for proration.**



Own Voices

Metered Access

- When you create a new cart for MA, you can optionally **designate it to use ARPA funds**.
- Any eligible MA by time titles **included in the cart** will have pricing & end dates adjusted in the cart details before purchase.
- Invoices for ARPA purchase orders (from ARPA designated carts) **will be separated** to let you easily track spending and issued at time of purchase.



Own Voices

Cost Per Circ

- Cost Per Circ (CPC) **does comply** for checkouts through September 30, 2022.



Schedule when to revoke

CPC will be removed early Eastern time on the selected date.

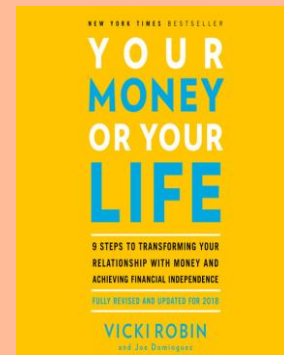
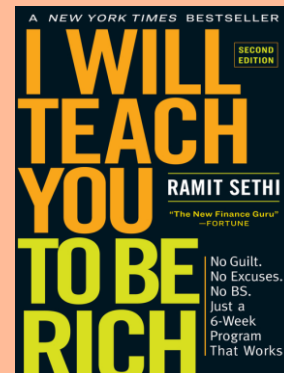
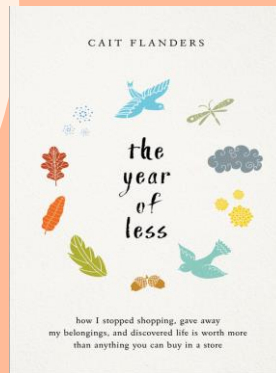

Clear

- Selectors can identify when they'll use ARPA funds for CPC.
- Invoices will be issued **monthly** as a **separate invoice** from other CPC content.

Simultaneous Use

- Simultaneous Use (SU) **does comply** if it is placed after June 1, 2021 and expires on or before September 30, 2022.
- Most publishers in SU offer 1-year subscriptions.

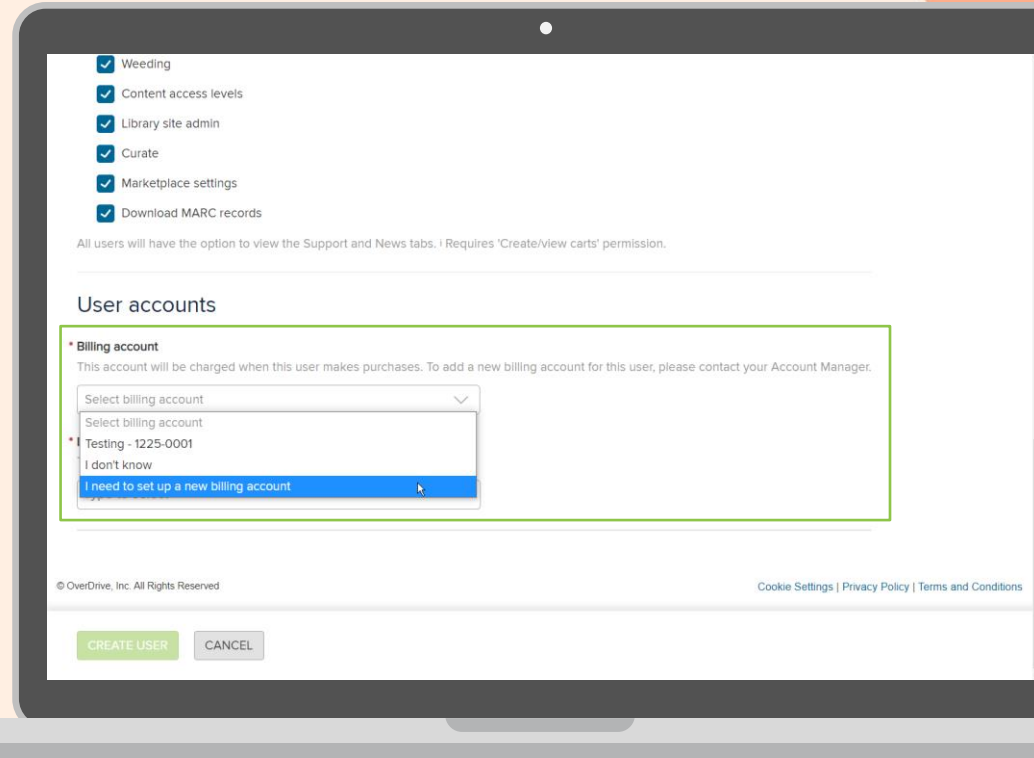

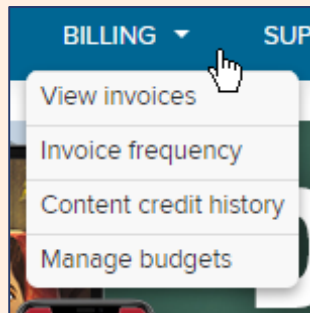
